As a parent or legal guardian of the youth participant, I hereby give my permission for my child to participate in the Greater Toledo International Youth Orchestra (GTIYO). I further understand that this is a full year commitment and my child is required to attend weekly Sunday afternoon practices at our designated practice facility from 2:00-4:45 PM (depending on group). My child will also receive some additional strings instruction either privately or through school orchestra. Each musician is responsible for bringing their instrument, music folder and stand (when needed) to all practices. I give my permission for my child to be photographed and/or videotaped during all GTIYO scheduled performances and activities. During international travel, my child will be a musical ambassador for the United States and the Greater Toledo area and will conduct themselves in accordance with the standards of behavior as outlined in the GTIYO Handbook. I agree to pay the annual cost of participation in full prior to the first performance (Fall concert). In addition, my child and I will participate in fund raising events and volunteer for the organization over the course of the year. Any personal contact information I disclose will only be shared by the fellow members of GTIYO, its Board of Directors, and its Conductors - Mr. Yang Kun Song and Mr. Colin Fetterly. I understand the registration dues are non-refundable and I will be required to purchase orchestra attire as outlined in the handbook for all performances.
